*Anyone seeking membership shall fill out a membership application form adopted by the Advisory Committee, which form shall be approved or disapproved by the committee, and sign a copy of the Etiquette, Rules and Regulations. All persons whose membership applications are approved shall be issued a membership card.*

**Membership Card**

*You as the primary member and your secondary member in good standing are welcome at Club 301. Your personalized, non-transferable card grants you access to the benefits and privileges of membership at Club 301 located in Lewiston, Id.*

**Member Guest**

*Members in good standing are allowed to bring up to 4 guests. Please note that also, subject to space availability, advance arrangements for larger groups can be made through Club 301@ 208-746-2005 x4.*

**Concert Ticket Availability**

*Members are given advance notification of all available upcoming Club 301 concerts and offsite events prior to the release of this information to the general public. (Eg: Boomtown Concerts) Please note: tickets, when available, are on "first come, first served" basis and quantities are limited.*

**Priority Concert/Special Event Seating**

*Reserved seating (if available) is limited and subject to a "first come, first served" allocation basis. Arrangements for Priority Seating at a Club 301 event or any other eligible off-site event can be obtained through Club 301 208-746-2005 x4*

**Special Club Events and Engagements**

*Each Club 301 Membership entitles you to a prearranged number of complimentary tickets to our Members Only events. Events include Sound Check sessions with national performing artists (when allowed by artist), Special Members Concerts, Cocktail Parties, Wine Tastings and more. Tickets are subject to availability.*

**Boomtown American Saloon Cover**

*Boomtown American Saloon has agreed to allow Club 301 members in good standing, to enter without a cover charge Friday and Saturdays before 10:30 p.m. This excludes special events and concerts.*

## **Member Benefits and Privileges Cont...**

### **Club 301 Communication**

*Club 301 keeps its members updated on all news and events from the Club 301 Meetings & Events via email and web. Every email and our web site contains information about member events as well as other items of interest, such as upcoming concerts and other news.*

### **Club 301 Hours of Operation**

*Standard hours of operation are: Monday through Saturday 4pm-Close. However, hours may vary. Club 301 is available to members for private events. Contact Club 301 to make arrangements. Please also note that Management reserves the right to close Club 301 to the Members to accommodate private membership functions.*

### **Total Membership**

*The maximum amount of members that will be allowed at this time is 300. This amount may be changed by the Advisory Committee as needed to ensure the success of Club 301.*

## **Etiquette, Rules, and Regulations Agreement**

**Upon signing, the following rules of etiquette constitute an agreement, enabling all to equally and fully enjoy the benefits of membership:**

### **Membership Cost**

*Members agree to pay the annual cost set forth for the use of Club 301 in accordance with the etiquette, rules, and regulations set forth in this agreement. Price of Memberships is subject to change. The current price for membership is as follows:*

*Primary Member: Initiation Fee \$100, Member Fee \$50 for first year Member Fees and \$20 for secondary Member Fees (wife, husband or significant other) Renewal Fees: \$50 annually for members, \$20 for secondary members. Note: If the secondary member during the year is replaced, a fee of \$10 will be charged for the new secondary member and the old secondary membership will be dropped.*

### **Club Account**

*Each Member (if desired) will have a Club 301 account set up in their name. At the end of each month (or after charging \$100.00) the total amount due will be charged to a credit card provided by the Member. Members are responsible for all charges made to their cards. Review and sign charges each time you charge.*

## **Etiquette, Rules, and Regulations Agreement Cont....**

### **Use of Membership Cards**

*Membership cards are issued to individuals directly and are expressly for their use. All cards are nontransferable. It is important for all members to have their membership cards in hand to gain access to Club 301. The use of your card by any other person is prohibited by this agreement. Misused cards will be confiscated. All lost or damaged cards will be reissued at a cost to members of \$5 per card.*

### **Dress Code**

*Club 301 Manager reserves the right to consult with you on appropriateness of attire. Advisory committee will monitor dress code and will adjust if necessary.*

### **Smoking**

*Cigarette, cigar and pipe smoking is allowed in designated area only.*

### **Liability for Personal Belongings**

*Club 301 does not accept responsibility for any personal items lost, stolen, damaged, or misplaced in the venue.*

### **Etiquette**

*In order to maintain an environment that is enjoyable, Club 301 reserves the right to ask a member or his/her guest(s) to leave Club 301 if:*

- Their behavior, language, or clothing is deemed inappropriate;*
- Their actions or conduct interfere with the enjoyment of other Club 301 Members and their guests;*
- They bring into Club 301 any intoxicating beverage, any illegal drug or controlled substance;*
- Their conduct or actions constitute any illegal, improper, or immoral behavior.*

### **Legal Claims**

*Club 301, and any and all agents of the same, shall not be responsible for any claims or judgments for damages and the like, including costs of defending against such claims arising out of personal injury or property damage occurring in connection with the use of Club 301 and all its areas by members or their invitees, unless such damage was caused by the gross negligence or willful misconduct of the party claiming such right to be indemnified or held harmless.*

### **Guest Privileges**

*Club 301 Members must accompany their guests. A Visit is defined as access to Club 301 by a non-member individual (Guest). A Guest is allowed a maximum of (4) Visits in one (1) calendar year regardless of the Sponsor Member. If the Guest is the visitor of different Members on separate occasions, each individual visit counts against the maximum allowed annual Guest Visits for the non-member individual. Members are responsible for the conduct of their visiting Guests.*

## **Etiquette, Rules, and Regulations Agreement Cont....**

### **Default / Cancellation of Membership**

*Breach of any term of this agreement by the member and/or their guests shall constitute default. Upon such an occurrence Club 301 reserves the right to cancel or revoke a membership, without recourse. Club 301 retains the right, under such circumstances, to terminate its obligation under this agreement and shall have any and all remedies available under applicable law, including without limitation the right to eject the member and/or their guests. The member shall be liable for all reasonable attorney fees and expenses incurred by Club 301 in connection with the enforcement of any of its rights or remedies hereunder. The failure by Club 301 to exercise any right or remedy hereunder shall not constitute a waiver or release thereof. In the event that a member cancels their membership or their membership is revoked prior to the end of their current membership term, no portion of the fee paid will be refunded. The undersigned agrees to all of the terms and conditions set forth herein, and in witness whereof they hereby execute this agreement.*
